8. That the school will ensure compliance of all statutory requirements like EPF, ESIC and labor laws etc with respect to the school and staff of the school.
9. That the school will ensure that the building safety, fire safety water safety health and hygiene certificate are being issued or renewed by the concerned municipal or state authorities from time to time as per the prescribed term.
10. That the school will ensure that all required infrastructure is available with school.
11. That school will ensure that sufficient number of qualified teachers as per the provisions contained in affiliation byelaws are available with the school.
12. That the school will follow the provisions related to fee contained and affiliation byelaws and will disclose the details of the fee to the students/parents every year before start of session without resorting to any hidden charges in the heads of the fee.
13. That the school will not coerce any students / parents to buy books /stationary/uniform from a particular shop.
